AN ORDINANCE RELATING TO THE OPENING OF A COUNTY ROAD IN AIRPORT GARDENS, PERRY COUNTY, KENTUCKY.

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF PERRY, COMMONWEALTH OF KENTUCKY.

SECTION I.

The hereinafter described road located at Airport Gardens, Perry County, Kentucky, shall be established pursuant to the provisions of KRS 178.080.

The road or street to be established is more particularly described as follows:

Beginning at Corner No. 1 of Larry & Kim Sizemore; thence N 40°21'21"W, 145.29 feet to a point on right side of road; thence N 26°01'09"W, 126.51 feet to a point on left side of road; thence N 29°05'21"W, 174.81 feet to a point on left side of road at driveway to Sherry and Earl Smith property; thence N 8°31'15"W, 192.82 feet to a point on right side of road; thence N 58°43'03"W, 73.58 feet to a point on right side of road at the switchback in the road; thence S 3°42'33"W, 361.54 feet to a point on left side of road; thence S 10°58'03"W, 309.55 feet to a point on right side of road; thence S 1°32'27"W, 260.89 feet to a point on left side of road; thence S 45°01'57"W, 186.89 feet to a point on left side of road; thence S 64°36'21"W, 155.89 feet to a nail in the blacktop at "The Lane" Street; thence running in reverse order these same calls back to the beginning. Said road is 12 feet wide at each station.

SECTION II.

The County Road Foreman shall cause notice of this establishment to be published pursuant to KRS 178.050 and shall in addition cause notice to be posted in the vicinity of the road pursuant to KRS Chapter 178.

SECTION III

Subsequent to the posting of the notice as set forth in the preceding paragraph. Dickie Vannarsdale and COLSON COURT shall be appointed as viewers, who, together with the road foreman, shall view the road and report in writing the advantages and disadvantages with which, in their opinion, will result to the public from the proposed work and other facts and circumstances that may enable the Fiscal Court to determine the propriety of this action.

This Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.


FIRST READING
