

# Public Hearing Notice

To all interested citizens of Perry County, Kentucky:  
The Kentucky Department of Local Government (DLG) is accepting applications under the 2017 Community Development Block Grant (CDBG) Program.

Perry County intends to apply for assistance to facilitate the creation of jobs by providing public assistance to allow for the construction of public facilities portion of a business development complex within Perry County Kentucky east of Hazard adjacent to KY HWY 80.

Perry County will hold a public hearing prior to the submission of the application. The public hearing will be held on Thursday, June 22<sup>nd</sup>, 2017 at 6:00 P.M. at the Perry County Courthouse, 481 Main Street – Fiscal Courtroom 1<sup>st</sup> Floor, Hazard KY 41701.

The purpose of this hearing is to obtain views on housing and community development needs, review proposed activities, review the proposed application, and solicit public comments. Technical assistance is available to help groups representing low and moderate income persons in developing proposals.

The following information concerning the CDBG program is available for public inspection at Judge Executive Scott Alexander's office during regular business hours 8:00 AM to 4:00 PM Monday thru Friday:

- A. Amount of funds available and range of activities that may be undertaken.
- B. Estimated amounts of funds proposed to be used for activities benefiting persons of low and moderate income.
- C. Plans for minimizing displacement of persons as a result of activities associated with CDBG funds and plans for providing assistance to those persons to be actually displaced as a result of CDBG-funded activities.
- D. Records regarding the past use of CDBG funds.
- E. A summary of other important program requirements.

#### Comments on Application

A copy of the CDBG application material will be on file at Judge Alexander's office for citizens' review and comment during regular business hours from 8:00 AM to 4:00 PM beginning Wednesday, June 14th, 2017 through Thursday June 22<sup>nd</sup>, 2017 until 4:00 PM. Comments on the proposed application may be submitted to the attention of Judge Scott Alexander until the close of business on June 22<sup>nd</sup>, 2017.
